1 Introduction

1.1 Definitions

In this document:

'APA' means APT Management Services Pty Limited ABN 58 091 668 110.

'Interconnect Facilities' means those pipeline facilities that are required to connect the Pipeline to the facilities of a person who receives or delivers gas on the Pipeline.

'Licence' means Pipeline Licence No 55 issued to the Service Provider by the State of Queensland under the Petroleum Act 1923, as in effect as of the date of this document.

'Service Provider' means Origin Energy Electricity Limited ABN 33 071 052 287.

'Pipeline' means:

- (a) the pipeline originating from the SWQP and terminating at the Roma Power Station, as fully described in the Licence; and
- (b) all ancillary equipment connected to that pipeline including any inlet and outlet stations, but not including any Interconnect Facilities or lateral pipeline facilities or any extension of the pipeline.

'SWQP' means:

- (a) the pipeline from Ballera to Wallumbilla in South-West Queensland, as fully described in the SWQP Licence; and
- (b) all ancillary equipment connected to that pipeline including any inlet and outlet stations, but not including any lateral pipeline facilities or any extension of the pipeline.

'SWQP Licence' means Pipeline Licence No 24 issued by the State of Queensland, as in effect as of the date of this document.

1.2 Purpose

The Service Provider is the owner of the Pipeline. The Pipeline is operated for Origin by APA.

The following information is provided as required by Part 23 of the National Gas Rules.

Please refer to the Roma Pipeline Access Guide if you are interested in acquiring gas transportation services from the Service Provider.

2 Pipeline Information

2.1 Pipeline classification

The Pipeline is a transmission pipeline.

2.2 Nameplate rating

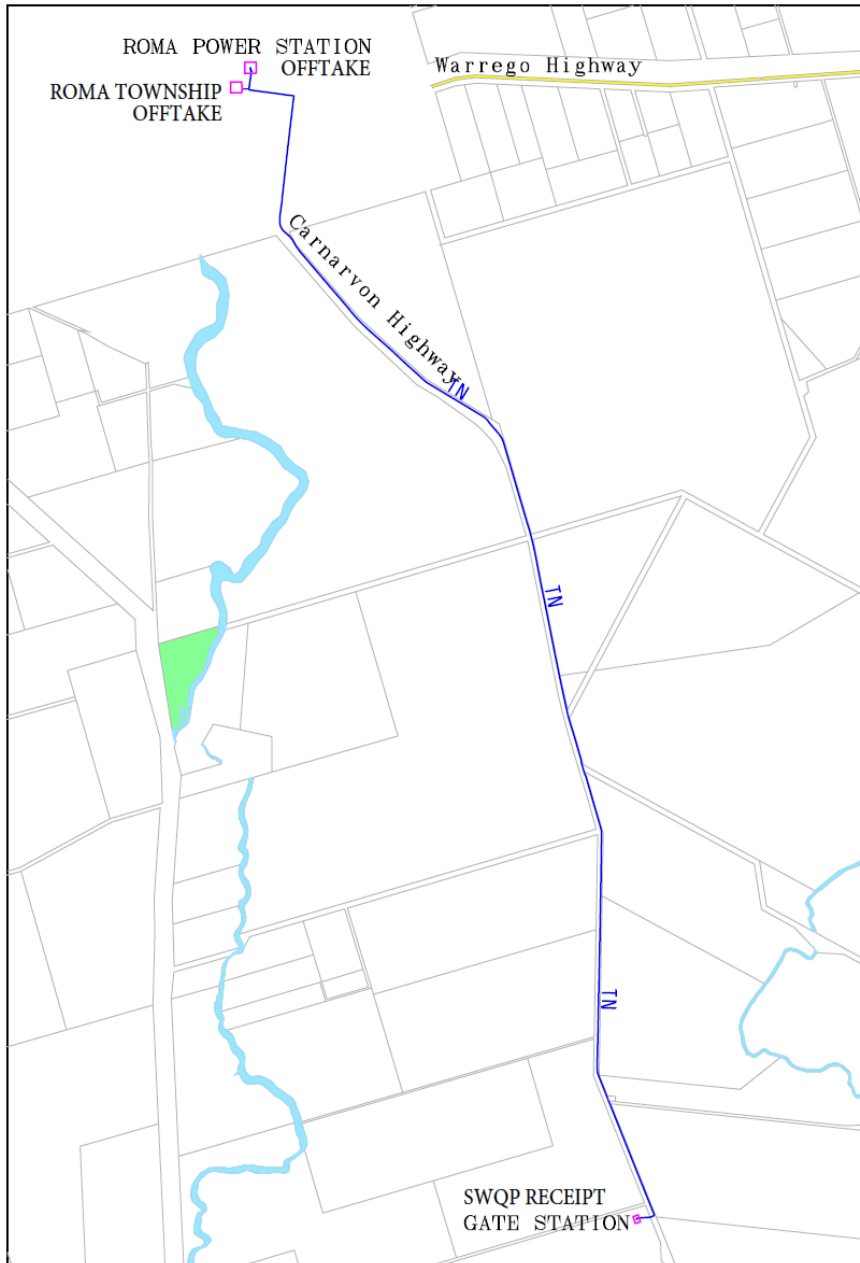
As per the definition in National Gas Rules 141(2), the Pipeline's nameplate rating is 19.2 TJ per day.

2.5 Technical or physical characteristics

The metering equipment at the SWQP Receipt point does not register small quantities of gas. As such, separate metering may need to be installed at user's cost.

The nameplate rating of the pipeline is restricted by physical equipment.

3 Pipeline service information

3.1 Haulage Services

- (a) The Pipeline Services which the Service Provider provides by means of the Pipeline are as set out below:

Name	Description	Locational limitations
Firm Service	Transportation of gas on a firm basis	None
Interruptible Service	Transportation of gas on an interruptible basis	None

- (b) Service Provider will provide each Haulage Service in accordance with, and subject to, the requirements of its Licence or applicable law.

3.2 Associated services

- (a) Each Haulage Service does not include a metering service or any other ancillary services.
- (b) The Service Provider may require a user or prospective user to provide meter reading data or agree to provide meter reading data or other ancillary services as agreed between the Service Provider and the user.

3.3 Priority

Service Provider will schedule gas deliveries in the following priority (or curtail gas deliveries in the opposite order):

- (a) Firm Service; then
- (b) Interruptible Service.
